1 Introduction

1.1 Purpose

This document outlines the NANP Notification System (NNS) tools associated with the **Subscription Choice** of **NANP Notification System (NNS)** in the web-based application of the NANP Administration System (NAS). The **Subscription Choice** of **NANP Notification System (NNS)** in NAS automates the search function of NNS notifications. NAS manages NNS notifications by electronic means so that any registered user can access them via a connection to the World Wide Web.

1.2 NANP Notification System (NNS) Subscription

The **Subscription Choice** of **NANP Notification System (NNS)** allows a user to submit and view data associated with NANP Notification System (NNS) notifications. In order to access the **NANP Notification System (NNS)** toolbar, the **Subscription Choice** of **NANP Notification System (NNS)** must be selected in the user's profile [see the appropriate *NANP Administration System (NAS) User Registration Guide*] based on the user type.

The NNS notification search options available will be based on user type and the **NANP Notification System (NNS) Resource Subscription** checkboxes selected in the user's profile.

1.3 Content Summary

This document will guide users through the search process for the following types of notifications in the NANP Notification System (NNS):

1.4 Related Documents

Other related documents include the user's specific User Type NANP Administration System (NAS) User Registration Guide (e.g., Service Provider/Service Provider Consultant, FCC/State Regulator, etc.).

1.5 Conventions

This document presents the text that appears on NAS screens (e.g., toolbar items, field labels and button text) as well as internal and external document references. Toolbar items, field names and internal document references are shown in **bold black**, internal document references are hyperlinked, and external document references are *black italicized*.

1.6 User Access

The data available to an active NAS user with the subscription of NANP Notification System (NNS) shall be restricted based on the user type selected, the NANP Notification System (NNS)

Resource Subscription checkboxes selected in the user's profile, and the State(s) and NPA(s) selected for geographic notifications.

NOTE: NPA Relief Planning notifications are only available to those entities directly involved in the development of area code relief plans.

NOTE: Suspended NAS users <u>will</u> continue to receive NANP Notification System (NNS) notifications but will <u>not</u> be able to use the NANP Notification System (NNS) function in NAS until they are active. Disabled NAS user will <u>not</u> receive NANP Notification System (NNS) notifications and will <u>not</u> be able to use the NANP Notification System (NNS) function in NAS until they are active.

1.7 Preparations

1.7.1 NANP Administration System (NAS) Registration

A user is required to have an approved user registration with the **Subscription Choice** of **NANP Notification System (NNS)** selected as the **Resource Subscription** selected in their user profile [see the User Type NANP Administration System (NAS) User Registration Guide].

1.7.2 Two-Factor Authentication

The NANP Administration System (NAS) requires two-factor authentication for FISMA compliance, therefore, NAS users are required to establish two-factor authentication in order to access the NAS (see the *Two-Factor Authentication User Guide*).

2 Login

To log in to NAS the user must be a registered user, have a valid and active username and password, and have established two-factor authentication.

2.1 NAS Log In

From the NANPA home page (<u>https://www.nanpa.com</u>), select **Login** located in the upper right corner (see in Figure 2-1), then **Log In To NAS** screen will be displayed (Figure 2-2).

The NAS Log In screen (Figure 2-2) allows the user to enter their login credentials. All fields with a red asterisk (*) are required.

The user must enter valid data for the following fields:

- Username
- Password

When all data is entered the user must select **Login**. When all validations are met, NAS will provide the **Multi-Factor Verification** screen (Figure 2-3).

2.2 Multi-Factor Verification

The user must enter the Two-Factor Authentication code associated with their NAS account. All fields with a red asterisk (*) are required.

The user must enter a valid:

• Verification Code

When all data is entered, the user must select **Verify**. When all validations are met, NAS will provide the **Dashboard**.

3 Access NANP Notification System (NNS) Toolbar

To access the NANP Notification System (NNS) toolbar, which includes all tasks outlined in 1.3 Content Summary, the user must have the Subscription Choice of NANP Notification System (NNS) in their user profile.

3.1 Accessing NANP Notification System (NNS) Toolbar

From the **Dashboard**, select **NANP Notification System (NNS)** from the toolbar (Figure 3-1).



4 Search NNS Notification

This section provides direction on the **Search NNS Notification** functions which allows the user to search the following notification types:

- Select All, which allows users to search all NNS notifications in NAS.
- **CO Code/Thousands-Block**, which allows users to search CO Code/Thousands-Block related NNS notifications in NAS.
- Jeopardy, which allows users to search Jeopardy related NNS notifications in NAS.
- Other Geographic Notifications, which allows users to search Other Geographic (e.g., press releases, regulatory directives, etc.) NNS notifications in NAS.
- NPA Relief Planning, which allows users to search NPA Relief Planning related NNS notifications in NAS.
- INC (Industry Numbering Committee) Guideline Changes, which allows users to search all INC Guideline Change NNS notifications in NAS.
- NRUF Reporting, which allows users to search NRUF Reporting NNS notifications in NAS.
- NANPA Planning Letters, which allows users to search NANPA Planning Letter NNS notifications in NAS.
- Other Non-Geographic Notifications, which allows users to search Other Non-Geographic NNS notifications (e.g., NANPA process/personnel changes, international numbering activities, NANP Exhaust forecasts, system maintenance, client education, etc.) in NAS.
- Other Resources, which allows users to search Other Resource (5XX-NXX, 9YY-NXX, CIC) related NNS notifications in NAS.
- **p-ANI**, which allows users to search p-ANI related NNS notifications in NAS.

From the **Dashboard**, select **NANP Notification System (NNS)** from the toolbar, then **Search NNS Notification** (Figure 3-1). NAS will provide the Search NNS screen (Figure 4-1).
