Abstract

This IL provides industry notification of the impending split of the 512 NPA.

We have been advised by Southwestern Bell that substantial telephone number growth in south Texas necessitates splitting the existing 512 NPA (area code) and the simultaneous introduction of a new 210 NPA. Both NPAs will have interchangeable central office codes (i.e., the second digit of a central office code may be any digit 0-9).

The new 210 NPA will include the San Antonio and Brownsville LATAs, while the Austin and Corpus Christi LATAs remain in the 512 NPA.

The split of the 512 NPA is scheduled for November 1, 1992. There will be a permissive dialing period starting on November 1, 1992 and ending on May 2, 1993. During the permissive dialing period either 512 or 210 will be acceptable in a dialed number terminating in the new NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information, based on data provided by Southwestern Bell, will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and be available April 1, 1992.

The dates that switching systems in the new 210 NPA will begin transmitting "210" in the calling number Automatic Number Identification (ANI) will be coordinated by Southwestern Bell with the interexchange carriers.

Test calls to verify routing to the new NPA can be made by calling (210) 222-4699. This test number will become available October 1, 1992, and remain operational for a minimum of 30 days after the end of the permissive period.

The attached map illustrates the 512 and 210 configuration after the split. Furthermore, a listing of the communities to be served by each area code after the split is included.



The dialing plan for the new 210 NPA will be the same as the dialing plan for the 512 NPA:

- All home NPA (HNPA) "local" calls (generally calls that do not incur a charge) will be dialed on a 7 digit basis with no prefix; i.e., NXX + XXXX (7 digits).
- All home NPA (HNPA) direct dialed "toll" calls (generally calls that incur a charge) will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All foreign NPA (FNPA) direct dialed calls must be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted local calls including credit card calls, collect, and third party will be dialed 0 + NXX + XXXX (0 + 7 digit).
- Operator assisted toll calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX.

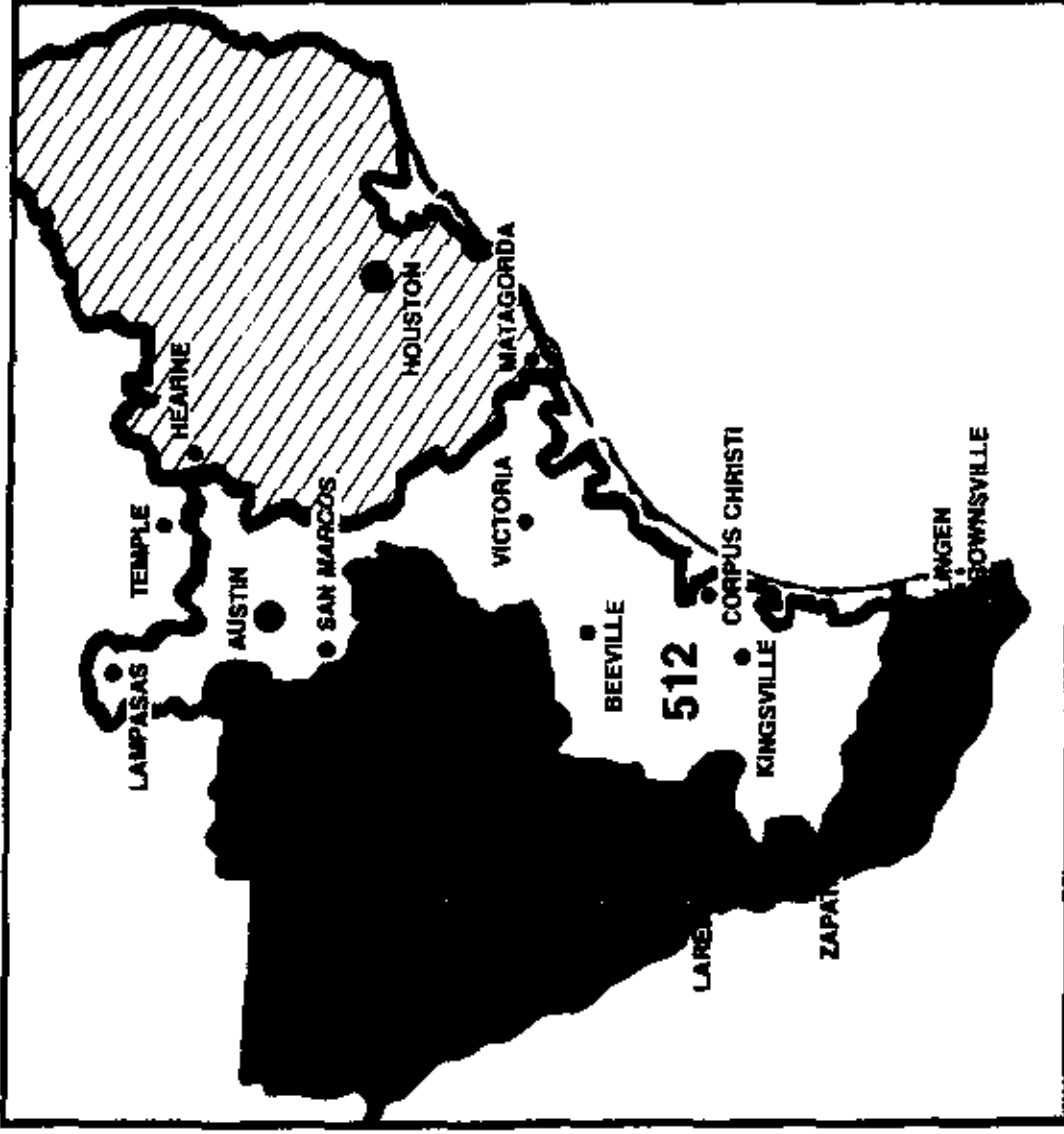
