Abstract

This IL provides industry notification of the following updates to previously released information letters:

- The transfer of 33 communities from the 706 NPA to the 404 NPA
- Change to a new test number for the 714/909 NPA split

(Includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by BellSouth Telecommunications that 33 communities currently included in the 706 NPA have been moved to the 404 NPA by order of the Georgia Public Service Commission. The 33 communities were previously assigned to the 706 NPA when the 404 NPA split on May 3, 1992. There will be a permissive dialing period for the 33 communities that is now in effect and will last until 2:00 AM Eastern Standard Time, Monday, March 29, 1993. During the permissive period either 706 or 404 will be acceptable for a call destined to these communities. A list of the 33 communities along with associated NXX code assignments is attached.

We have also been advised by Pacific Bell that there is a change to the previously announced test number of (909) 909-2000. The new number (909) 688-0030 should now be used for testing purposes. The new test number is now available and will remain operational at least until September 14, 1993.
