Subject: NANP-Split of 810 (Michigan) Numbering Plan Area (NPA)

We have been advised by Ameritech that substantial number growth in the southeastern portion of Michigan necessitates splitting the existing 810 NPA and the simultaneous introduction of a new NPA 248. The following is a description of this relief plan.

Oakland County will receive the new 248 NPA. Customers in Macomb, St. Clair, Sanilac, Lapeer, Genesee, and the affected parts of Livingston counties will retain the 810 NPA.

The split of the 810 NPA and the beginning of a permissive dialing period are scheduled for 12:01 AM EDT on Saturday, May 10, 1997. The permissive period will end at 12:01 AM EDT on Saturday, September 13, 1997. During the permissive period, either 810 or 248 will be acceptable in a dialed number terminating in the new 248 NPA. After the permissive period, calls dialed with an incorrect NPA code, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

The attached map illustrates the 810 and 248 configuration after the split, showing approximately where the boundary between the NPAs will be located. Also attached are listings of all assigned NXXs within the 810 and 248 NPAs as of September 23, 1996. For each NPA, one listing shows the NXXs sorted in numerical order, and another listing shows the NXXs by community sorted in alphabetical order. Revisions to the NXX listings may be found either in the Local Exchange Routing Guide (LERG) or the NPA NXX Activity Guide (NNAG). Current information concerning NXXs in these publications is available by license contract from Bellcore's Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at 908-699-6700.

All international and domestic carriers are asked to ensure that the new 248 NPA has been activated throughout their networks prior to May 10, 1997. Test calls to verify routing to the new 248 NPA can be made by dialing: 248-253-9717. The test number will be operational from within the 248 NPA on April 26, 1997. It is not expected the test number can be reached from outside the 248 NPA until shortly before the beginning of permissive dialing. Calls successfully completed to the test number will receive a recorded announcement. The test number will be disconnected on October 11, 1997.

The dialing procedures for the 810 and 248 NPAs will be as follows:

- All home NPA (HNPA) local calls will be dialed on a 7-digit basis with no prefix, i.e., NXX + XXXX (7 digits).
- All HNPA toll calls, i.e., calls that generally incur an extra charge, will be dialed with a prefix "1" and 10 digits, i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).

- All foreign NPA (FNPA) calls will be dialed with a prefix "1" and 10 digits, i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).

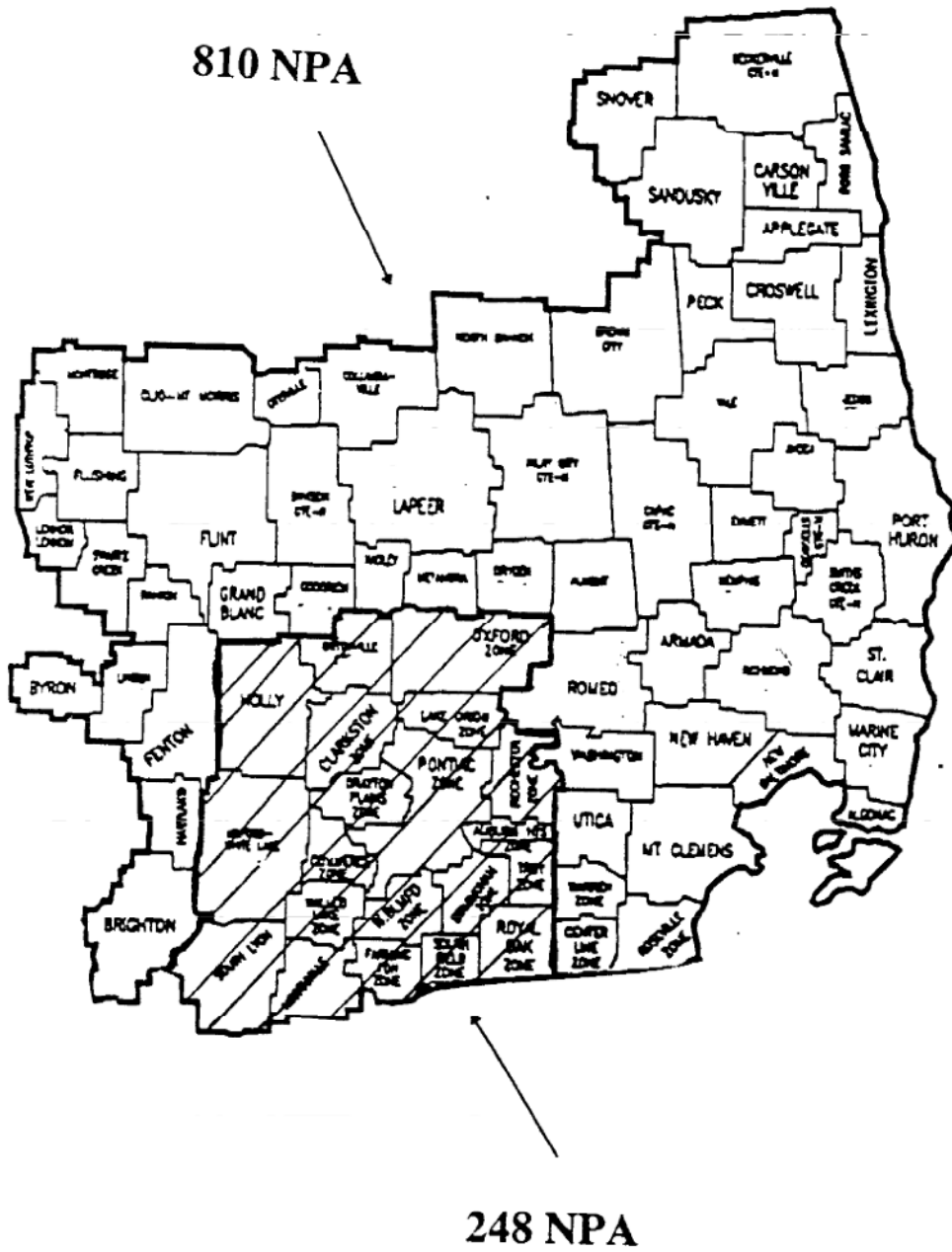
