Subject: NANP-Split of 414 (Wisconsin) Numbering Plan Area (NPA)

---

We have been advised by Ameritech that substantial number growth in Wisconsin necessitates providing area code relief for the 414 NPA. The relief plan, approved by the Public Service Commission of Wisconsin, calls for a geographic split of the 414 NPA and the simultaneous introduction of a new 920 NPA. The following is a description of this relief plan.

Milwaukee and the surrounding communities south of it will retain the 414 NPA while the exchanges in the northern portion of the current 414 NPA will receive the 920 NPA code.

The split of the 414 NPA, and the beginning of a permissive dialing period, will take place at 12:01 AM Central Daylight Time (CDT) on Saturday, July 26, 1997. The permissive dialing period for wireline carriers will end at 12:01 AM CDT on Saturday, October 25, 1998. The permissive dialing period for wireless carriers will end at 12:01 AM CDT on Monday, October 25, 1999. This will primarily affect wireless carriers in the Green Bay Local Access and Transport Area (LATA). During the permissive dialing period, either the 414 or 920 NPA code will be acceptable in a dialed number terminating in the new 920 NPA. After the permissive period, all calls dialed with the incorrect NPA code will be routed to intercept.

The attached map illustrates the 414 and 920 NPA configuration after the split. Also attached are listings of the assigned central office codes (NXXs) and the communities in the 414 and 920 NPAs after the split. The NXX information is effective as of December 19, 1996. Since NXX information may change over time, updated NXX information may be found either in the Local Exchange Routing Guide (LERG) or the NPA NXX Activity Guide (NNAG). Current information in the LERG and NNAG is available by license contract from Bellcore's Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at 908-699-6700.

All international and domestic carriers are asked to ensure that the new 920 NPA has been activated throughout their networks prior to July 26, 1997. Test calls to verify routing to the new NPA can be made by dialing 920-448-0050, effective July 14, 1997. Calls successfully completed to the test number will receive a recorded announcement. The test number will be disconnected at the end of permissive dialing on October 25, 1998.


The dialing plan for the 414 and 920 NPAs will be as follows:

- All home NPA (HNPA) local calls will be dialed on a 7-digit basis, i.e., NXX-XXXX (7 digits).
- All home NPA (HNPA) toll calls, i.e., calls that generally incur an extra charge, will be dialed with a prefix "1" and 10 digits, i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).

- All foreign NPA (FNPA) local calls and toll calls will be dialed with a prefix "1" and 10 digits, i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).

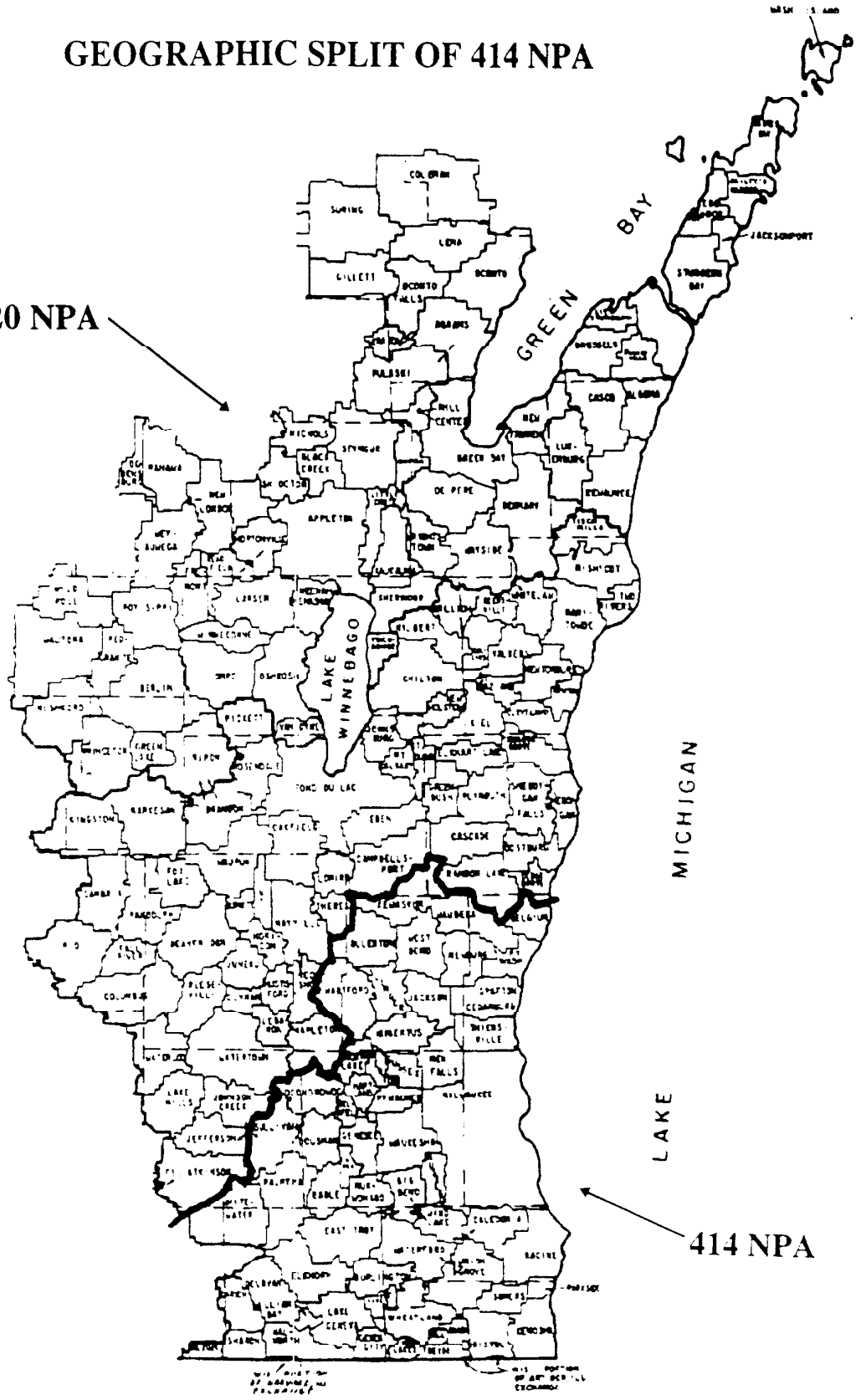
