Subject: NANP-Concentrated Overlay of 305 Numbering Plan Areas (NPA) in Florida

We have been advised by BellSouth that substantial telephone number growth in Dade County, Florida necessitates the activation of an additional NPA to serve this area. The relief plan approved by the telecommunications industry in the area calls for a concentrated overlay, and NANPA has assigned the 786 NPA code to Florida for this purpose. In the NPA overlay plan, the new 786 NPA will overlay the 305 NPA and will become effective on March 1, 1998. Although most overlays share the same geographic boundaries, the 786 NPA will not share the same geographic boundaries as the 305 NPA, as illustrated on the [attached maps](#). Miami-Dade County will have 786 overlay, while Monroe County which comprises the Florida Keys, will not be a part of the 786 overlay.

In preparation for the introduction of the overlay code and mandatory 10-digit local dialing for the Miami area, a permissive dialing period will begin on March 1, 1998, during which subscribers will be encouraged to dial 10 digits (i.e., NPA + NXX + XXXX) for all local calls and extended area service calls both within and between the 305 and 786 NPAs. Beginning July 1, 1998, all local calls within and between the NPAs involved in the overlay will require 10 digits. BellSouth has indicated that the permissive dialing period has been established to ready the network and to provide customers the opportunity to become comfortable with the new dialing patterns. No NXX assignments will be made in the new 786 NPA until after July 1, 1998.

The attached [map](#) illustrates the 305 and 786 NPA configuration after the overlay.

After the beginning of mandatory 10-digit dialing on July 1, 1998, the dialing plan for the 305 and 786 NPAs will be as follows:

- All home NPA (HNPA) and foreign NPA (FNPA) local calls and Extended Area Service (EAS) calls will be dialed on a 10-digit basis without a prefix, i.e., NPA + NXX + XXXX (10 digits).
- All HNPA and FNPA toll calls and Extended Calling Service (ECS) calls, i.e., calls that generally incur an extra charge, will be dialed with a prefix "1" and 10 digits, i.e., 1 + NPA + NXX + XXXX (1 + 10 digits).
- All operator-assisted calls, including credit card, collect, and third party calls, will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX.

All international and domestic carriers are asked to ensure that the new 786 NPA has been activated throughout their networks prior to March 1, 1998. Test calls to verify routing to the 786 NPA has can be made by dialing the following test number, effective March 23, 1998, is 786 242-9998. Calls successfully completed to the test number will receive a recorded announcement. The test call will be discontinued after July 1, 1998.

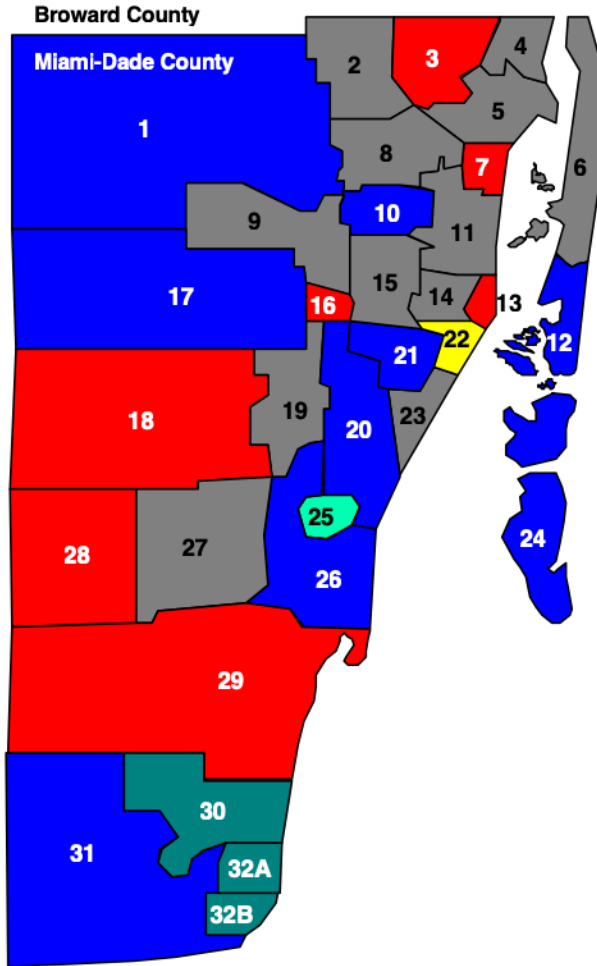
