Subject: Geographic Split of 414 (Wisconsin) Numbering Plan Area (NPA); addition of 262 NPA

As a result of substantial number growth in Wisconsin, the 414 NPA is nearing exhaust. The relief plan, approved by the Wisconsin Public Service Commission, calls for a geographic split of the 414 NPA and the simultaneous introduction of a new NPA, 262. The 414 NPA will continue to serve customers in the mideastern portion of the existing 414 NPA around the city of Milwaukee. The 262 NPA will serve the remaining portion of the existing 414 NPA, as shown on the attached map. After the split, exhaust of both the 414 and 262 NPAs is expected to occur in the year 2007, based on current demand projections.

Also attached are lists of current 414 NPA central office codes (NXXs) that will remain in the 414 NPA and that will move to the 262 NPA. The lists are correct as of April 20, 1999. Since NXX information may change over time, consult either the *Local Exchange Routing Guide* (LERG) or the *NPA NXX Activity Guide* (NNAG) for updated information. The LERG and NNAG are available from Telcordia's Traffic Routing Administration, 732-699-6700.

The split of the 414 NPA will occur at 12:01 a.m. Central Daylight Time on Saturday, September 25, 1999. A five-month permissive dialing period will begin simultaneously with the split and end at 12:01 a.m. Central Standard Time on Saturday, March 4, 2000. During the permissive dialing period either the 414 or the 262 NPA code will be acceptable in a dialed number terminating in the 262 NPA. After the permissive period, all calls dialed with the incorrect NPA code will be routed to an informational announcement. Activation of reassigned 414 codes begins May 3, 2000.

After the beginning of mandatory dialing on March 4, 2000, the dialing plan for the 414 and 262 NPAs is as follows:

- All home NPA (HNPA) calls, including local and Extended Area Service (EAS), will be dialed either on a 7-digit basis with no prefix -- i.e. NXX+XXXX (7 digits), or, optionally, with a prefix "1" and 10 digits (1 + NPA + NXX + XXXX)

- All foreign (FNPA) calls terminating in NPAs other than 414 and 262 will be dialed with a prefix “1” and 10 digits – i.e., 1+FNPA+NXX+XXXX (1 + 10 digits)
- All calls between 414 and 262 will be dialed on a 1 + 10-digit basis, 1+FNPA+NXX+XXXX, or when the Local Exchange Carrier elects to exercise the option of 10-digit dialing, FNPA+NXX+XXXX (10 digits).
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a “0” prefix and 10 digits – i.e., 0+NPA+NXX+XXXX (0 + 10 digits)

All international and domestic carriers should ensure that the new 262 NPA can be translated throughout their networks no later than September 25, 1999. From May 29, 1999, until April 4, 2000, test calls to verify routing to the 262 NPA can be made by dialing 262-821-9999. A recorded announcement will indicate successful completion of the call.

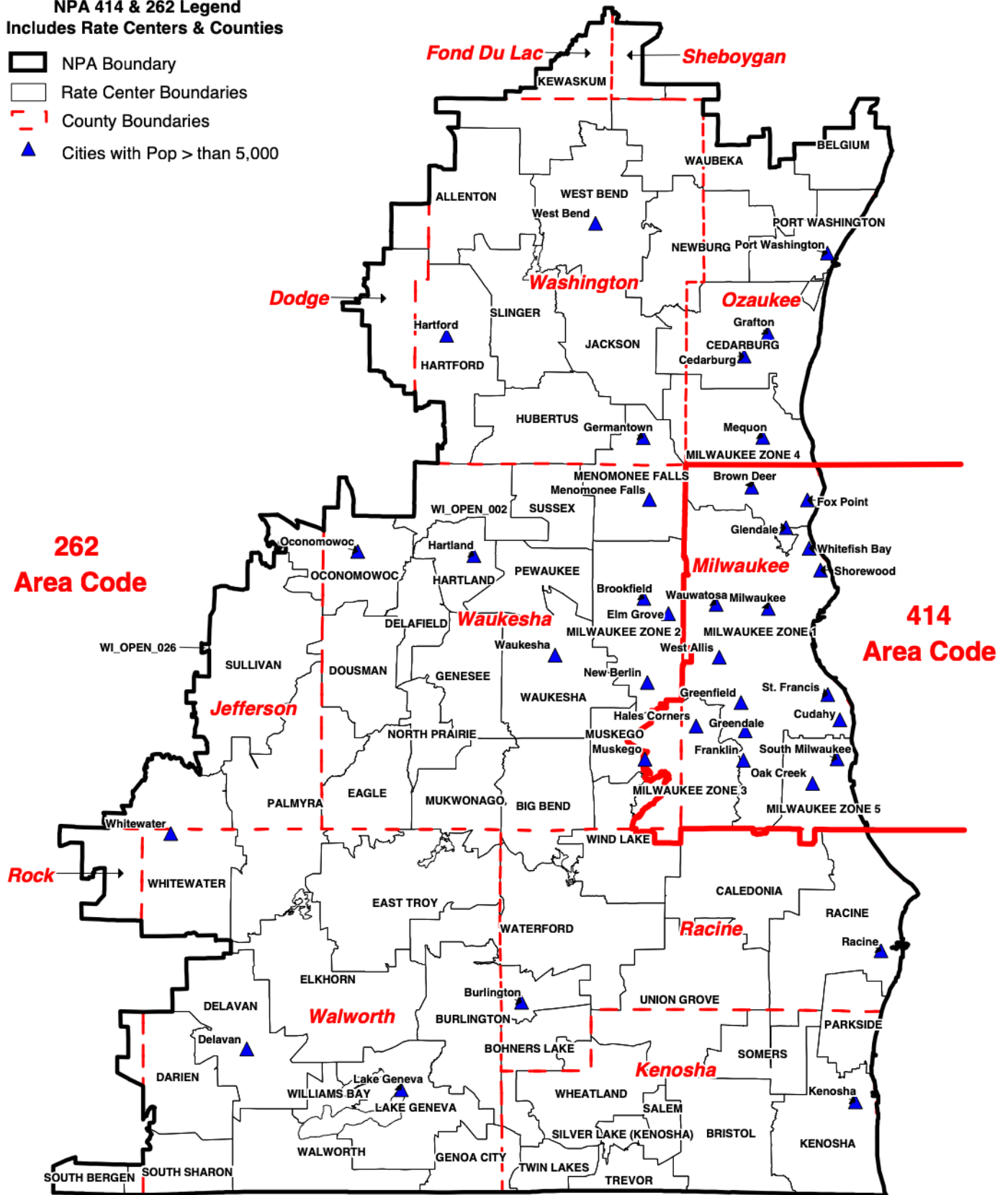
