Subject: NPA 737 to Overlay NPA 512 (Texas)

On March 29, 2000, the Public Utility Commission of Texas issued an order in Project Number 21772 for the relief of the 512 NPA. The relief plan calls for an concentrated growth overlay of the Austin Metropolitan Area and Interstate 35 Corridor, including Austin, Georgetown and San Marcos. NPA code 737 has been assigned to the overlay area.

As required by the FCC, 10-digit dialing will be introduced in the concentrated overlay area prior to the effective date of the overlay. Beginning at 12:01 AM Central Daylight Time August 4, 2001, subscribers are encouraged to dial 10 digits (NPA+NXX+XXXX) for all local calls originating or terminating within the overlay area. After 12:01 AM Central Standard Time on November 10, 2001, all local calls will require 10 digit dialing. The 737 NPA will be implemented on November 10, 2001.¹

The attached map illustrates the 512 and 512/737 NPA configurations after the implementation of the overlay. Also attached is a listing of the rate centers in the concentrated overlay area of the 512 NPA.

After the introduction of the overlay on November 10, 2001, the dialing plans for the overlay area (512/737) and the non-overlay area (512) are as follows:

Dialing plan for calls originating from the overlay area (512/737)

- All local calls that terminate in the overlay area (512/737), including those made by customers with Extended Area Service (EAS) and Extended Local Calling (ELC), will be dialed with ten digits (NPA+NXX+XXXX).
- All local calls terminating outside the overlay area (512/737), including those made by customers with EAS and ELC, will be dialed with ten digits (NPA+NXX+XXXX).
- All toll calls will be dialed as ten digits with the prefix "1" (1+NPA+NXX+XXXX).
- All operator-assisted, third-party and credit card calls will be dialed as ten digits with the prefix "0" (0+NPA+NXX+XXXX).

¹ Per the PUCT order, PUCT staff will present an evaluation of number conservation measures no later than June 1, 2001 and may revise the implementation timeline.

Dialing plan for calls originating from the non-overlay area (512)

- All local calls terminating in the non-overlay area (512) made by customers who do not have local calling into the overlay area (512/737) will be dialed with seven-digits (NXX+XXXX).
- All local calls terminating in the overlay area (512/737) made by customers having EAS or ELC into the overlay area will be dialed with ten digits (NPA+NXX+XXXX).
- All local calls terminating in a foreign NPA will be dialed with 10 digits (NPA+NXX+XXXX).
- All toll calls will be dialed as ten digits with the prefix "1" (1+NPA+NXX+XXXX).
- All operator-assisted, third-party and credit card calls must be dialed as ten digits with the prefix "0" (0+NPA+NXX+XXXX).

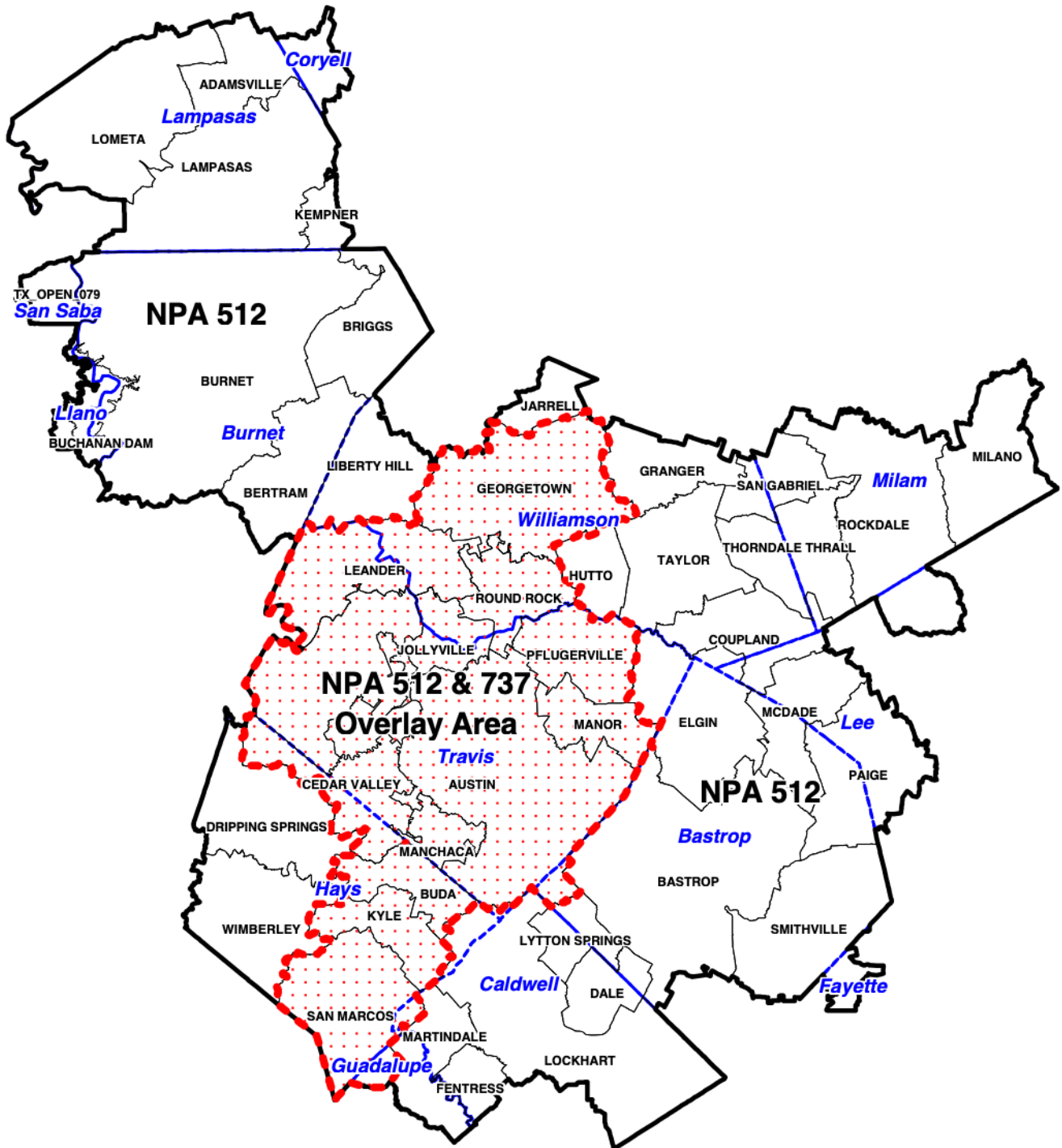
All international and domestic carriers should ensure that the new 737 NPA code has been activated throughout their networks prior to November 10, 2001. At this time a test number is not available. NANPA will publish the test number in an updated version of this Planning Letter.
