Subject: NPA 754 To Overlay NPA 954 (Southeast Florida)

In Docket 990455-TL, the Florida Public Service Commission (FPSC) approved an all-services overlay of the 954 NPA that serve Broward County (Ft. Lauderdale), Florida. NANPA has assigned NPA code 754 for this purpose. At that time, the FPSC declined to order implementation. Order NO. PSC-01-1403-PCO-TI, issued June 28, 2001 orders implementation of the approved Relief Plan.

The implementation is to occur in two phases.

The first phase began August 1, 2001 with the activation of the new 754 NPA. Local dialing will be as follows:

The second phase, Beginning May 1, 2002 will have the following local dialing plan:

During both phases and continuing after the September 1, 2002 date, the following dialing plan for toll and operator assisted calls is to be used:

- All toll calls must be dialed as 1 + 10 digits; i.e., 1-NPA-NXX-XXXX.
- Operator assisted, third party, and credit calls must be dialed as 0 + ten digits; i.e., 0-NPA-NXX-XXXX.

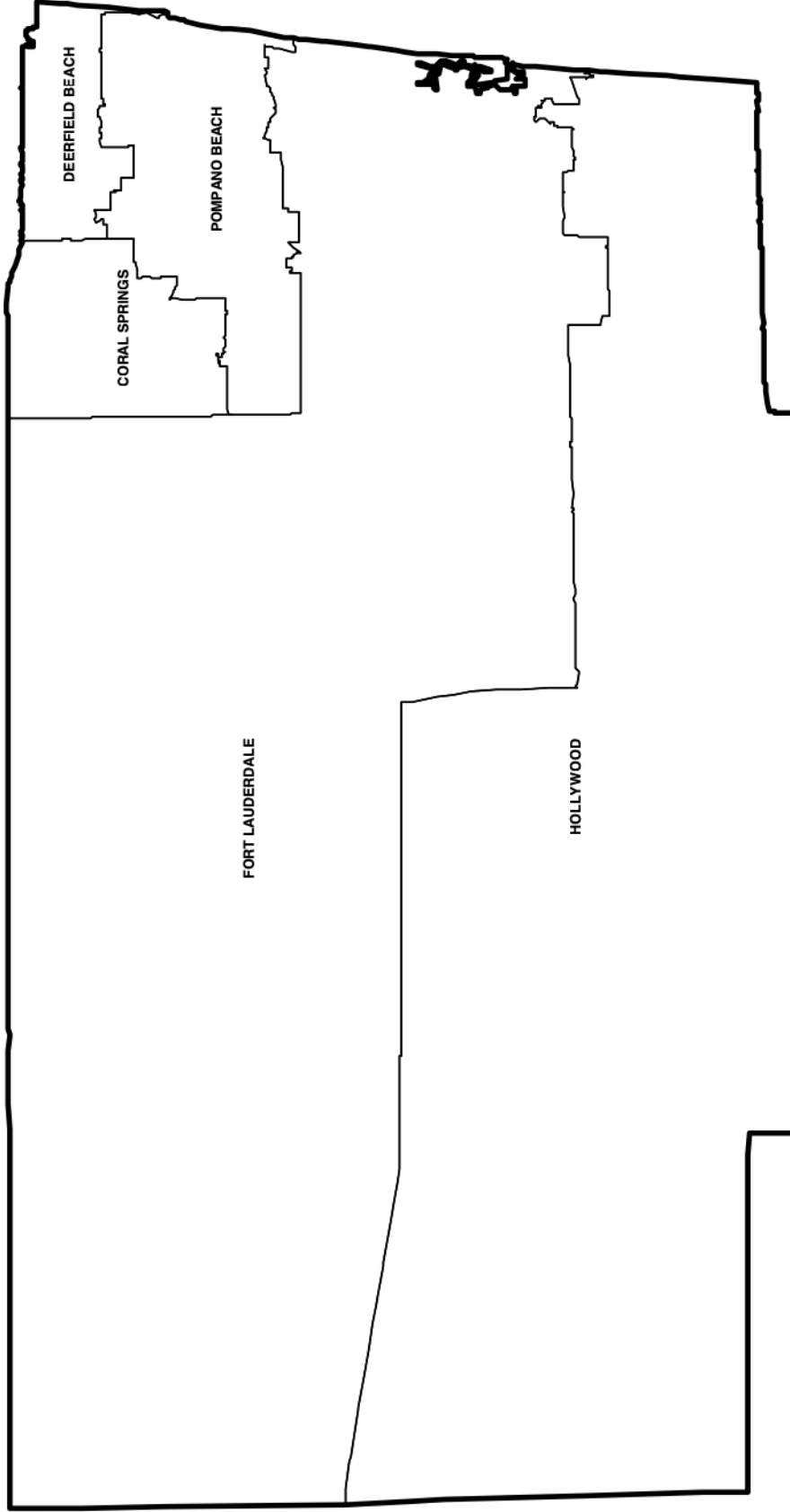
All international and domestic carriers should have ensured that the new 754 NPA code has been activated throughout their networks prior to September 1, 2001. Test calls to verify routing to the new 754 NPA can be made by dialing the test number 754-910-9998. The test number will be available no later than September 1, 2001. It will remain available until October 1, 2001. A recorded announcement will indicate that the test call has been successfully completed. Answer supervision will be provided on this test number. A second test number, 754-910-9999, may be used for milliwatt testing.

NXX codes within the new 754 NPA may be assigned to service providers after July 19, 2001, but assigned codes may not be activated prior to September 23, 2001.
