This Planning Letter supersedes Planning Letter 395 dated August 26, 2009.

This revision makes changes to the Carriers' and Test numbers list to include TELUS Communications (Québec) Inc. test numbers.

In Telecom Decision CRTC 2009-453, dated 28 July 2009, the Canadian Radio-television and Telecommunications Commission (CRTC) directed that relief for Québec area code 450 be provided through a distributed overlay of a new area code 579 starting 21 August 2010. This Decision varies previous Telecom Decision CRTC 2009-255.

New area code 579 has been assigned by the North American Numbering Plan Administrator and will be implemented on the Relief Date of 21 August 2010 as a distributed overlay over the geographic area of Southern Québec currently served by the 450 area code. The area served by NPA code 450 and the new 579 NPA code includes the major communities of Joliette, Granby, St-Hyacinthe, St-Jérôme, St-Lambert, Longueuil, Valleyfield, Ste-Thérèse, Sorel, Boucherville, Chomedey, St-Jean, Pont-Viau, and Laval-Ouest. A map showing the location of the area served by NPA 450, and a list of the 128 Exchange Areas in the area are attached to this letter.

When the new 579 NPA is introduced, no changes will take place in the dialling plans in the area that is served by NPA 450 and will be served by NPA 579. The dialling plan in this area will be:

- all local calls including Extended Area Service calls will be dialled with 10 digits
- toll and alternatively billed calls will be dialled with 10 digits after the appropriate prefix digit(s)

All international and domestic Telecommunications Service Providers (TSPs) should activate the new 579 NPA throughout their networks by the start date for network testing (19 June 2010).

The following test numbers for the new NPA 579 will be made available effective 19 June 2010. Routing of calls to NPA 579 can be verified by dialling the 8378 (TEST) numbers which do not

provide answer supervision. Billing of calls to NPA 579 can be verified by dialling the 2455 (BILL) numbers which provide answer supervision.

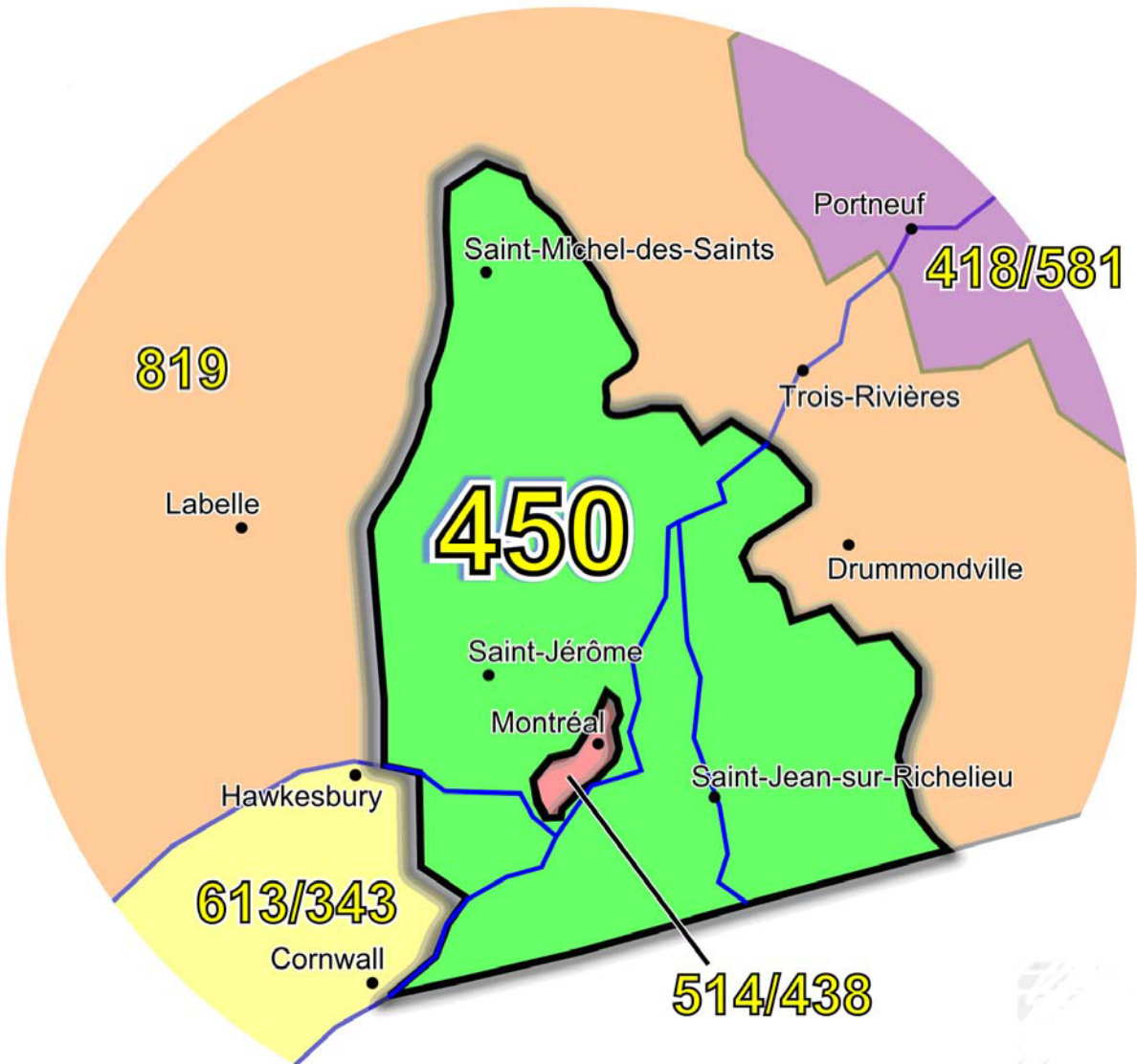
The disconnection dates for the Test numbers will be between 21 September 2010 and 21 October 2010.

Central Office (NXX) Codes within NPA 579 may be assigned to TSPs starting from 21 February 2010, but cannot be activated in the PSTN prior to the Relief Date of 21 August 2010.
