## This Planning Letter replaces Planning Letter 407R1 dated August 17, 2010.

In November 1999, the Industry Numbering Committee directed NANPA to assign the 855 NPA code for toll-free service. On June 25, 2010, the Wireline Competition Bureau of the Federal Communications Commission (FCC) authorized the opening of the 855 toll free code commencing at 12:00 p.m., Eastern Time, Friday, October 1, 2010. On August 2, 2010, in response to the Alliance for Telecommunications Industry Solutions' SMS/800 Number Administration Committee (SNAC) request to modify the October 1, 2010 date for opening the 855 toll free code, the FCC agreed to delay the opening by 24 hours, to Saturday, October 2, 2010, at 12:00 pm, to lessen the impact on regular customer activities that take place during the normal business week.

On September 30, 2010, the Wireline Competition Bureau ordered the establishment of an allocation method for the release of the 855 toll free code. In addition, they delayed the October 2, 2010 code opening one week, to October 9, 2010, to allow all Responsible Organizations (RespOrgs) time to review the FCC's allocation scheme and make any necessary preparations.

## **General History**

On November 29, 1999, the Industry Numbering Committee (INC) directed NANPA to assign the 866 and 855 NPA codes for toll-free service, supplementing the 800, 888 and 877 NPAs. (See Planning Letter 197). The 866 NPA code went into service in July 2000, but the implementation of the 855 NPA was deferred until further notice.

On March 10, 2010, DSMI (Database Service Management Inc.), the Federal Communications Commission (FCC) designated Toll Free Number Administrator, notified the FCC of the pending shortage of Toll Free numbers. Specially, DSMI forecasted that the current supply of toll free numbers was expected to reach the 90% threshold in the 4Q2011. As a result, DSMI requested the FCC to approve the release of the 855 NPA for implementation no later than the 4Q2011.

On May 27, 2010, the Alliance for Telecommunications Industry Solutions (ATIS), on behalf of the SMS/800 Number Administration Committee (SNAC), informed the FCC the most recent toll free number assignment data suggested that exhaust may occur by January 2011, if not sooner. Due to the importance of this resource to the industry, ATIS urged the FCC to inform

the industry of the anticipated schedule for the release of the new 855 code so that appropriate steps could to be taken to ensure an orderly rollout.

On June 25, 2010, the FCC, based upon the most recent exhaust analysis, which indicated that the supply of current toll free numbers was expected to last until November 21, 2010, authorized DMSI to open the 855 toll free NPA on October 1, 2010.

On August 2, 2010, per the request of the SNAC, the FCC delayed the opening of the 855 toll free NPA to 12:00 pm ET, October 2, 2010.

On September 30, 2010, the FCC delayed the opening of the 855 toll free NPA one week to 12:00pm ET, October 9, 2010.
