Subject: NPA 609 and 640 All-Services Overlay (New Jersey)

General Description

On April 21, 2017 the New Jersey Board of Public Utilities (BPU) in Docket TO13121166 approved an all-services overlay as the relief method for the 609 NPA. The area served by the 609 NPA includes portions of central and southeastern New Jersey. The new **640 NPA Overlay** will be an all-services overlay and will serve the same geographic area currently served by the existing 609 NPA. Additionally, the BPU ordered the elimination of protected codes between the 609 and 856 NPAs, which allowed 7-digit dialing to certain NXX codes to the adjacent NPA. 1+10-digit dialing to these NXX codes will be required. A list of protected codes in each of the NPAs is shown below. The permissive dialing period will also be provided to transition away from these protected codes.

Implementation of Relief Plan

Implementation of the 609-640 NPA overlay and elimination of protected codes is as follows:

During the permissive dialing period, subscribers may dial calls within the overlay area on either a 7-digit or 10-digit basis, but will be encouraged to dial 10-digits. After the permissive period ends, all calls must be dialed using 10-digits.

Dialing Plan

Coincident with the introduction of mandatory 10-digit dialing on August 18, 2018 the dialing plan for the 609 and 640 NPAs will be as follows:

Local or Toll call	Home NPA (HNPA)	10-digits (NPA-NXX-XXXX)*
Local or Toll call	Foreign NPA (FNPA)	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

*1+10-digits for HNPA calls permissible at each service provider's discretion

Network Testing

All international and domestic carriers should ensure that the new 640 NPA has been activated throughout their networks prior to September 17, 2018. The test number to verify the routing to the 640 NPA will be in service beginning June 6, 2018 through October 17, 2018. The test number to verify the routing to the 640 NPA is: 640-990-TEST (8378). A recorded announcement will indicate the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.
