General Description

On June 21, 2018 the California Public Utilities Commission (CPUC) in Decision 18-06-013 approved an all-services distributed overlay as the relief method for the 510 NPA. The area served by the 510 NPA includes the western portions of Alameda and Contra Costa Counties. The 510 NPA serves the cities of Alameda, Albany, Berkeley, Emeryville, Fremont, Hayward, Newark, Oakland, Piedmont, San Leandro and Union City in Alameda County; and the cities of El Cerrito, Hercules, Pinole, Richmond, and San Pablo in Contra Costa County. The new **341 NPA Overlay** will be an all-services overlay and will serve the same geographic area currently served by the existing 510 NPA.

Implementation of Relief Plan

Implementation of the 510/341 NPA overlay is as follows:

During the permissive dialing period, subscribers may dial calls within the overlay area on either a 7-digit or 1+10-digit basis, but will be encouraged to dial 1+10-digits. After the permissive period ends, all calls must be dialed using 1+10-digits.

Dialing Plan

Coincident with the introduction of mandatory 1+10-digit dialing on June 22, 2019, the dialing plan for the 510 and 341 NPAs will be as follows:

Network Testing

All international and domestic carriers should ensure that the new 341 NPA has been activated throughout their networks prior to July 22, 2019. The test number to verify the routing to the 341 NPA will be in service beginning April 22, 2019 through August 22, 2019. The test number to verify the routing to the 341 NPA is: 341-341-1341. A recorded announcement will indicate the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions.
