Subject: NPA 943 and 404/470/678/770 All-Services Overlay (Georgia)
Related Previous Planning Letters: 555, 269, 102, IL95/06-008

This planning letter supersedes PL-555. This planning letter includes revised implementation and network testing intervals.

General Description

On October 6, 2020 the Georgia Public Service Commission (PSC) in Docket No. 43466, approved an all-services distributed overlay as the relief method for the 404/470/678/770 NPA. The 404/470/678/770 NPA currently serves the metropolitan area of the City of Atlanta including but not limited to Alpharetta, Duluth, Dunwoody, East Point, Forest Park, Gainesville, Griffin, Lawrenceville, Mableton, Marietta, Peachtree City, Roswell, Sandy Springs, Smyrna and Tucker. The new 943 NPA will serve the same geographic area currently served by the existing 404/470/678/770 NPA. Additionally, the order specifies that central office codes in the 943 NPA will be available for assignment only when all assignable prefixes in the 404/470/678/770 area codes have all been exhausted.

Implementation of Relief Plan

Implementation of the 404/470/678/770/943 NPA overlay is as follows:

Network Testing

All international and domestic carriers should ensure that the new 943 NPA has been activated throughout their networks prior to March 15, 2022. The test number to verify the routing to the 943 NPA will be in service beginning December 15, 2021 through April 15, 2022. The test number to verify the routing to the 943 NPA is: 943-943-1943. A recorded announcement will indicate the test call has been successfully completed.

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.
