Subject: NPA 645 and 305/786 All-Services Overlay (Florida)
Related Previous Planning Letters: 468, 287, 116

General Description

On February 24, 2022, the Florida Public Service Commission (Commission), in Docket No. 20210190-TP, approved an all-services distributed overlay over the 305/786 NPA. The 305/786 NPA serves Miami-Dade County and a portion of Monroe County and includes communities such as Miami, Homestead and the Florida Keys as well as other smaller communities. The new **645 NPA** will serve the same geographic area currently served by the existing 305/786 NPA. Additionally, central office codes in the 645 NPA will be available for assignment only when all assignable prefixes in the 305/786 NPA have been assigned.

Implementation of Relief Plan

Implementation of the 305/786/645 NPA overlay is as follows:

Network Testing

All international and domestic carriers should ensure that the new 645 NPA has been activated throughout their networks prior to August 4, 2023. The test number to verify the routing to the 645 NPA will be in service beginning May 4, 2023, through September 4, 2023. The test number to verify the routing to the 645 NPA is: 645-645-1645. A recorded announcement will indicate the test call has been successfully completed.
