**Subject:** NPA 274 and 920 All-Services Overlay (Wisconsin)  
**Related Previous Planning Letters:** 586, 556, 544, 442, 417, 385, 040

**This Planning Letter supersedes PL-586 and includes revised implementation and network testing intervals.**

**General Description**

On December 8, 2008 the Public Service Commission of Wisconsin in Docket 5-TN-106, approved an all-services distributed overlay as the relief method for the 920 NPA. The 920 NPA covers most of the northeastern portion of Wisconsin. It serves communities including but not limited to Appleton, Beaver Dam, Berlin, Fond du Lac, Fort Atkinson, Green Bay, Manitowoc, Oshkosh, Ripon, Sheboygan, Sturgeon Bay and Watertown. The new **274 NPA** will serve the same geographic area currently served by the existing 920 NPA. Additionally, Central Office (CO) codes in the 274 NPA will be available for assignment only when all assignable CO codes in the 920 NPA have been exhausted.

**Implementation of Relief Plan**

Implementation of the 920/274 NPA overlay is as follows:

## Dialing Plan

The dialing plan for the 920/274 NPAs overlay is as follows:

\*1+10 digit dialing for all calls permissible at each service provider's discretion.

## Network Testing

All international and domestic carriers should ensure that the new 274 NPA has been activated throughout their networks prior to May 5, 2023. The test number to verify the routing to the 274 NPA will be in service beginning February 5, 2023 through June 5, 2023. The test number to verify the routing to the 274 NPA is: 274-274-0274. A recorded announcement will indicate the test call has been successfully completed.

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.
