Subject: NPA 357 and 559 All-Services Overlay (California)

General Description

On December 14, 2023, the California Public Utilities Commission in Application 23-01-012, Decision 23-12-012, approved an all-services distributed overlay as the relief method for the 559 NPA. The 559 NPA is in Central California in the San Joaquin Valley. It includes all or portions of Fresno, Madera, Mariposa, Merced, Tulare, and Kings counties and serves communities including, but not limited to, Clovis, Coalinga, Fresno, Madera, Porterville, Reedley, Selma, and Visalia. The new **357 NPA** will serve the same geographic area currently served by the existing 559 NPA. Additionally, central office (“CO”) codes in the 357 NPA will be available for assignment only when all assignable CO codes in the 559 NPA have been assigned.

Implementation of Relief Plan

Implementation of the 559/357 NPA overlay is as follows:

Start of permissive 1+10-digit dialing	August 26, 2024
Earliest date CO codes in the new 357 NPA may be ordered through NANPA*	January 19, 2025
End of permissive dialing and start of mandatory 1+10-digit dialing	February 26, 2025
Earliest new 357 CO code activation date**	March 26, 2025

* CO codes in the 357 NPA available only when all assignable CO codes in the 559 NPA are assigned.

Dialing Plan

Coincident with the introduction of mandatory 1+10-digit dialing on February 26, 2025, the dialing plan for the 559 and 357 NPAs will be as follows:

Local Call	Home NPA (HNPA) or Foreign NPA (FNPA)	1 + 10-digits (1 + NPA-NXX-XXXX)*
Toll Call	HNPA or FNPA	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

*10-digit dialing permissible at wireless providers' discretion

Network Testing

All international and domestic carriers should ensure that the new 357 NPA has been activated throughout their networks prior to March 26, 2025. The test number to verify the routing to the 357 NPA will be in service beginning December 26, 2024 through April 26, 2025. The test number to verify the routing to the 357 NPA is 357-357-1357. A recorded announcement will indicate the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.
